**LEASE ADDENDUM**  
**(Required for all Tenants of Ventura at Turtle Creek COA, Inc)**

This Lease Addendum is entered into by \_\_\_\_\_

between Landlord and Tenant.

Tenant hereby acknowledges receipt of the Association's Covenants and Restrictions, Bylaws, and Rules and Regulations, and specifically agrees to abide by same at all times. Tenant and Landlord agree that the Association is hereby named as a party to the subject Lease Agreement with the following rights:

- 1.) The Association shall have the appropriate standing and the right to evict Tenant for any material violation of the Covenants and Restriction or Rules and Regulations subject to the statutory provisions of the Florida Residential Landlord and Tenant Act, FL ST § 83.40, et seq. (2009);
- 2.) Should the Landlord be in arrears with regard to its individual assessment account, the Association may make demand in writing to Landlord and Tenant via U.S. Certified Mail (RRR), that rent payments be made by Tenant directly to the Association until the individual assessment account is made current. Landlord waives any objection to the foregoing assessment payment mechanism. Should Tenant refuse to render rent payments directly to the Association, notwithstanding Landlord's delinquency, the Association shall have standing to proceed with an eviction action pursuant to FL ST § 83.56, et seq. (2009); and
- 3.) Landlord hereby agrees to hold Tenant harmless for any actions Tenant makes in compliance with this Lease Addendum and which are necessitated by Landlord's delinquent Association assessment account.

The Lease Agreement is hereby approved and ratified in total by the undersigned Parties.
